Membership is open to...

- Individuals/Households who reside in or are owners of real property within the boundaries of the Hamlets of Flanders, Riverside and Northampton, and
- Individuals who are business owners/Operators who maintain a business located within the boundaries of the Hamlets of Flanders, Riverside and Northampton.

Each individual who is eligible for membership as described above is entitled to one membership. If an individual owns or leases more than one residence or business, said individual will be entitled to one membership only. Application shall be accompanied by payment of the first year's annual dues. The payment of dues is a pre-requisite to membership.

Household Memberships: Residents over the age of 18 living in a single household are eligible to be members. Individual applications will still need to be filed for Official Membership Counts. Application shall be accompanied by payment of the first year's annual dues. The payment of dues is a pre-requisite to membership.

BENEFITS OF MEMBERSHIP

Benefits of all paid memberships in this association include:

- Strong leadership and a representative voice in the goal to lead the three hamlet communities of Flanders, Riverside and Northampton into prosperity by improving services, securing benefits and civic improvements, addressing current issues directly affecting our community, and in obtaining economic advantages for the betterment of the residents and business owners within the three hamlets.
- Cohesiveness and alliances among residents and community members.
- Participation in sponsored cultural, civic, charitable, social events and activities.
- Annual membership identification card (required to be presented at any meeting at which a vote will take place).
- The right to vote on issues brought before the general membership and to cast ballots in the election of officers.
- Publicity detailing the efforts of the association and upcoming events.

ADDITIONAL BENEFITS FOR ALL PAID MEMBERSHIPS FOR BUSINESS OWNERS INCLUDE:

- Community support to business owners of projects and efforts that are deemed by the general membership to be beneficial to the hamlet communities of Flanders, Riverside and Northampton.
- Promotional efforts and advertisements in newsletters and the association's website including a website presence including logo on the website homepage and an individual webpage.
- Activities that promote trade, services and commerce for business establishments within our three communities.

DUES

Amount of Dues: Individual Membership is \$20. Household Membership is \$30
Business Owners/Operators Membership is \$75. Dues are not refundable.

Due Date: Annual dues are due on March 1 of each year.

Unpaid Dues: Members whose dues are not paid shall have no right to vote or to enjoy any privileges of membership.

Arrears: Members whose dues are not paid in full within thirty (30) days of the due date will be considered in arrears. The Membership Committee shall notify members whose dues are thirty (30) days in arrears. The Membership Committee shall report any memberships that are sixty (60) days in arrears to the Executive Board of the Association, whereupon if so ordered by said Executive Board, such members in arrears shall be removed from the rolls. Such members shall forfeit all rights and privileges of membership.
