Call to Order, Pledge, Roll Call: The Flanders, Riverside, Northampton Community Association Meeting for January 22, 2007 was called to order at 7:10 p.m. by Michael Brewer. Old Minutes: The minutes from November 27, 2006 were read and a motion was made by Michael Brewer to accept the minutes with corrections, seconded by Ellen Rausch.

Riverhead Central School District Board meeting to be held on January 23, 2007. Michael Sacco will attend this meeting specifically to discuss the problem of not teaching the children cursive writing at the Phillips Avenue Elementary School. Capital budget items are on the agenda.

February 5, 2007 – Riverhead Central School District meeting for school superintendent search.

February 6, 2007 – Vote on Capital Budget Projects discussed on January 23, 2007 from 6:00 to 9:00 PM at Riverhead High School.

Committee Reports:

Beautification: The Riverside corner is completed except for the perennial plantings, which are planned for this Spring.

Chris Sheldon will submit design for Northampton signs.

Government: Setbacks are requested for owners at 45 Maple Avenue and 219 Flanders Blvd.

Membership: Laura Smith reported that the membership renewals will soon be mailed out to the community.

Old Business:

Michael Brewer and Carl Iacone met with Supervisor Heaney and Town Clerk Sundry Schermeyer regarding the handbills and flyers left in driveways. It was discussed if it would be possible to enact a resolution to change from automatic delivery to delivery only on request.

New Business:

There is no total as yet of the cost of our Holiday party.

The water supply has been shut down for the winter on the Route 105 corners.

Assessments worked out for fair market value were generally approved.

Michael Brewer and Carl Iacone will meet with Supervisor Heaney to discuss the new Flanders Fire Department substation on Flanders Road and school taxes.

Michael Brewer has telephoned Senator LaValle regarding the \$1.3 million to alleviate school taxes being deposited in Riverhead Central School District general fund. He has not received a response from the Senator.

Topics to be discussed: Can reassessments be done for Riverhead residents?

Can mandate be enacted?

Permanent PILOTS needed. Disbursement of the funds needs to be addressed.

Money should be held in escrow by Southampton Town to relieve Riverhead School District taxes.

Representatives of the Flanders Fire District will be guest speakers at our general meeting on February 26, 2007. The need for the new substation will be discussed.

No one in the community was notified of plans concerning the Black Duck Lodge. It was suggested that we need to contact Jay Schneiderman regarding happenings in our community and have the Town designate contacts for any future happenings in our community.

Scholarship Fund: There is \$1000.00 available for the 2007 scholarship fund. Motion by Michael Brewer to award a scholarship and seconded by Eugene Rausch. All were in favor.
